SUMMARY OF GRANT PURPOSE

The undersigned hereby agrees, in consideration of the receipt of the above reference grant, that grant funds will be used **ONLY** for the scope and purposes requested.

It is agreed that:

1. Any portion of the funds not used within the stated scope of the work or program or for the stated purposes unless prior written approval has been obtained for any significant variance, shall be repaid.
2. A report narrative shall be submitted once the funds are expended (or sooner at the request of the grantor) detailing expenditures of the grant amount. The report should contain:
 - a. a narrative account of what was accomplished, making clear how the grant monies were spent, and
 - b. a pictorial accounting and/or an itemized receipt of what the grant supported.

Denton Bible Church (herein, "Church") is awarding this grant contingent upon the following conditions:

You are required to provide the Church with immediate notification of any significant changes in your organization's structure or operation, if you are unable to expend the grant for the purpose described above, or if any expenditure from this grant has been made for any purpose other than those for which the grant was intended. Any portion of the funds not used for the purpose stated above, must be immediately returned to the Church.

You are required to submit a written report on the manner in which these grant funds were spent and the progress made in accomplishing the purpose of the grant. This report shall supply sufficient information as necessary for the Church to determine that the funds were used for the intended purposes.

You will permit the Church, at its request, to have reasonable access to your files, records, and personnel for the purpose of making such financial audits, verifications or program evaluations, as it deems necessary concerning this grant award.

No part of the grant funds is to be used to carry on propoganda, or otherwise attempt to influence legislation, or to influence the outcome of any specific public election. No part of the grant funds shall inure to the benefit of any individual Church employee or Board Member.

Governing Law:

This agreement shall be governed by the law of the State of Texas both as to interpretation and performance. Venue shall be Denton County, Texas.

Arbitration Provision:

In the event of any disputes, claims or controversies between the parties gereto arising out of or relating to this Agreement, it is agreed that such disputes, claims or conroversies shall be submitted to binding argitration in Denton County, Texas, under the then existing rules, guidelines, procedures and supervision of the Institute for Christian Conciliation, or similar faith-based mediation and arbitration group. In the event the Institute for Christian Conciliation ceases to exist during the course of this Agreement, arbitration under this section shall be conducted according to the rules of the American Arbitration Association. Judgment upon an arbitration award may be entered in any court otherwise having jurisdiction. Church and Grantee each agree to bear their own individual costs related to any conciliation, mediation or argitration proceeding.
