**SCOPE OF USE-** User will use the Vehicle only for personal or routine business use, and operate the Vehicle only on properly maintained roads and parking lots. User will comply with all applicable laws relating to holding of licensure to operate the vehicle, and pertaining to operation of motor vehicles.

**CONDITION OF VEHICLE-** User understands that no promises are made otherwise than what is contained in this Agreement, that no warranties have been made that the Vehicle will be adequate for User's planned use, and that User accepts the Vehicle in an AS IS condition. User has inspected the vehicle to be used and has independently determined that it is suitable and safe for their User's particular purpose. If the Vehicle is damaged or destroyed while it is in the possession of User, User agrees to notify church administration immediately of accident, to pay any required insurance deductible and also assign all rights to collect insurance proceeds to Denton Bible Church.

**INDEMNIFICATION-** User agrees to indemnify, defend, and hold harmless the Denton Bible Church for any loss, damage, or legal actions against Denton Bible Church as a result of User's operation or use of the Vehicle during the term of this Agreement. This includes any attorney fees necessarily incurred for these purposes. User will also pay for any toll fees, parking tickets, moving violations, or other citations received while in possession of the Vehicle. User represents and warrants that User is legally entitled to operate a motor vehicle under the laws of this jurisdiction and will not operate it in violation of any laws, or in any negligent or illegal manner.

**JURISDICTION AND VENUE-** Any and all claims or disputes arising from or related to this Agreement, other than a claim for injunctive relief, shall first be submitted to mediation in Denton County, Texas in accordance with the then governing rules of The Institute for Christian Conciliation. If the parties cannot resolve their dispute through mediation, they shall have the issue resolved through arbitration with the then governing rules of The Institute for Christian Conciliation. In the event that the Institute for Christian Conciliation ceases to exist during the course of this Agreement, arbitration under this section shall be conducted according to the rules of the American Arbitration Association. Judgment upon an arbitration award may be entered in the District Court for the County of Denton, Texas. Property Denton Bible Church and Temporary User shall bear their own costs related to any mediation or arbitration proceeding.
